A. Objective of Admission

Kaohsiung Medical University (KMU), Taiwan, College of Life Sciences, Department of Medicinal and Applied Chemistry, launched a new graduate program titled “International Master's Program for Talent Cultivation in Electronic Materials (INTENSE Program)” to welcome international students to pursue a Master’s degree at KMU, Taiwan. This program is approved by the Ministry of Education (MOE), Taiwan.

The Department of Medicinal and Applied Chemistry, College of Life Sciences at KMU is dedicated to cultivating talents in life sciences and chemistry for both industrial and research applications. Equipped with advanced research facilities and an outstanding faculty, the college offers programs covering a wide range of academic fields, including biotechnology, medicinal chemistry, and biomedical sciences. Through interdisciplinary research and industry-academic collaboration, the college drives advancements in the biotechnology and healthcare industries. In addition to providing students with academic training and practical experience, the Department of Medicinal and Applied Chemistry, College of Life Sciences collaborates closely with KMU’s four affiliated hospitals. It actively engages in research related to medicinal chemistry, biomedical materials, drug synthesis and trace analysis, biotechnology, and the development of specialty chemicals. This program at KMU is specially designed for international students. B. Qualification

➤ Status Eligibility

Applicants shall meet the following requirements, cited from the latest [*Regulations Regarding International Students Undertaking Studies in Taiwan*](#):

Article 2



A person of foreign nationality who has never held Republic of China (“R.O.C.”) nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

1. The person has never undertaken studies in Taiwan as an overseas Chinese student.
2. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

1. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
2. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.
3. A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent authority gives approval.

The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The term “overseas” used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

1. attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;



2. spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
3. spent a total period of less than two years in Taiwan as an exchange student; or
4. spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

In these Regulations a person to whom any of the circumstances set out in Article 2 of the Nationality Act apply is deemed to have Republic of China (“R.O.C.”) nationality.

Article 3

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.

A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

The term “resided [...] continuously” in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed



is not counted when calculating the period that they resided continuously overseas referred to in the previous paragraph.

The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The definition of “overseas” given in Paragraph 5 of the previous article also applies, mutatis mutandis, to Paragraphs 1 to 4.

Article 4

An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students.

An international student in any of the following circumstances, who after applying to study in Taiwan in accordance with the preceding paragraph, is applying to continue studying in Taiwan, or is once again applying to study in Taiwan, is not subject to the restriction set out in the preceding paragraph.

1. If an international student is applying for admission to a master’s degree or higher-level program after completing the course of study at the educational institution to which they originally applied, the university to which the student is now applying shall handle the application in accordance with its regulations;
 2. If an international student applied to come to Taiwan to undertake a bachelor's degree or lower-level program in Taiwan and after coming to Taiwan stayed for less than one year for some reason then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such further application is permitted.
 3. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to an associate degree program or a program below that level.
 4. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to a bachelor’s degree program other than one in a university department of medicine, dentistry, or Chinese medicine; only one such further application is permitted.
- If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous two paragraphs.

➤ **Educational Eligibility**

A Bachelor's degree or higher obtained from a university or an independent college recognized by M.O.E. should be verified by R.O.C. representative office. Should the applicant has completed the study in accordance with the provisions of Article 4, Paragraph 2 of the *Regulations Regarding International Students Undertaking Studies in Taiwan*, a certificate of “being enrolled via International Students Admission Channel in a bachelor's degree program or higher” is required, e.g. the Acceptance Notice for International Students from the educational institution which they originally enrolled. If the educational institution didn't offer such a document, [Appendix 1](#), stamped by the original educational institution, should be submitted as an alternative.

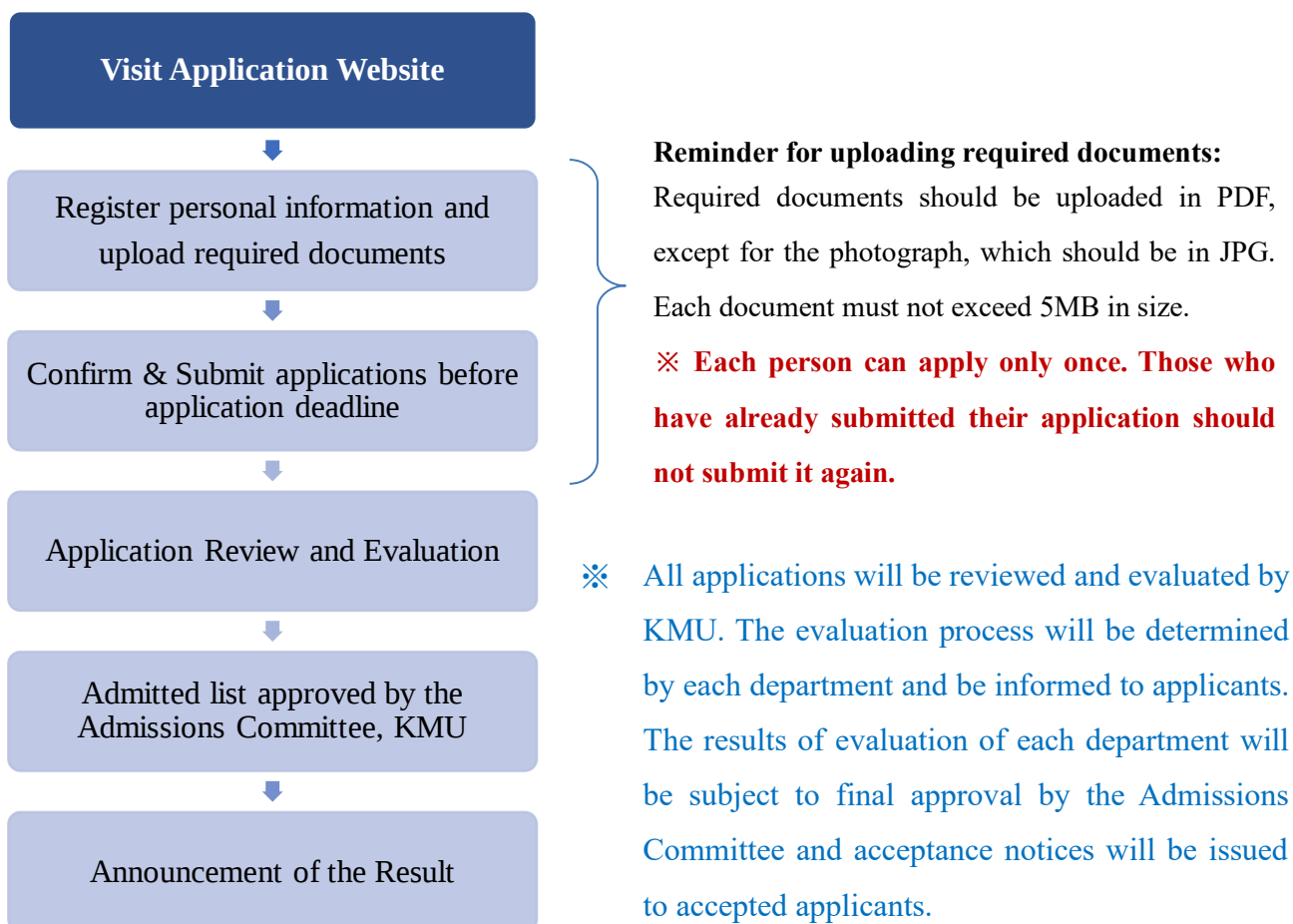


C. Application Procedure and Admission Eligibility Review Procedure

Please visit Application Website to complete the online application, and upload the required documents.

Applications without online registration will not be accepted.

To ensure timely communication regarding your application, please use your regularly checked personal email address when applying, as most admission information will be communicated via email. (Please also monitor your spam folder to avoid missing important messages.)

The website does not require login and has no auto-save function. Applicants are advised to complete the online application in one session without interruption. Please fill out the form in one sitting, as your responses will not be saved until you submit. **Late applications will not be accepted.**

KMU will comply with the provisions of the *Personal Information Protection Act* of the R.O.C. government and relevant regulations to collect, process, and utilize the personal information of the candidates. D. Required Documents

1. **Application Form** completed online through the application system
2. **The highest-level diploma** verified by R.O.C. representative office. (Chinese or English translation is required if the transcript is in neither of the languages aforementioned.)
 - (1) Academic credentials:
 - a. Academic credentials from Mainland China: The *Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area* shall apply.
 - b. Academic credentials from Hong Kong or Macao: The *Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao* shall apply.
 - c. Academic credentials from other areas:
 - i. Academic credentials earned at overseas Taiwan schools or Taiwan schools in Mainland China shall be regarded as the same as those at domestic schools with equivalent levels.
 - ii. Academic credentials from overseas other than those referred to preceding 2 items shall be handled in accordance with the provisions of the *Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education*. However, academic credentials earned from institutes or branches established in Mainland China by foreign schools shall require public notarization in Mainland China and be verified and examined by an institute established or appointed by or through a private agency commissioned by the Executive Yuan.

Applicants graduating in the current year shall submit “the certificate of expected graduation” or “the certificate of enrollment.”
 - (2) For international students who have completed their bachelor’s degree program or higher in Taiwan:

They shall provide a certificate of “being enrolled via International Students Admission Channel in a bachelor’s degree program or higher”, e.g. the Acceptance Notice for International Students from the educational institution which they originally enrolled. If the educational institution didn’t offer such a document, [Appendix 1](#), stamped by the original educational institution, should be submitted as an alternative.
3. **Official transcripts** verified by R.O.C. representative office. (Chinese or English translation is required if the transcript is in neither of the languages aforementioned.)

※ Master’s degree programs applicants should provide Bachelor’s degree (or above) official transcripts of every semester. The transcripts must include the Grade Point Average (GPA), the ranking within the class or department, and explanation of grading system. If the explanation is not provided, the Score/GPA will be converted in accordance with [KMU’s Grade Conversion Guide](#).
4. **Financial statement** issued by a bank within the past 6 months, showing a current balance of at least NT\$120,000 / US\$4,000, to demonstrate sufficient financial resources for study in Taiwan, or official



proof of a scholarship provided by a government, university, college, or private organization. For the financial statement, acceptable documents may include a bank balance certificate or an official bank statement. Copies or photographs of passbook pages are not accepted. For the scholarship, proof issued by agencies, companies, or individuals is not accepted.

- a. The bank statement shall be issued by the bank officially with the information of current balance and currency, and be authenticated by R.O.C. representative office in/near the applicant's country.
- b. Financial statements from a Taiwanese bank or a branch of a foreign bank located in Taiwan do not need to be authenticated.
- c. If the bank statement does not belong to the applicant, a signed statement from the account holder is also required, stating the holder's relationship with the applicant and guaranteeing to cover the applicant's expenses in Taiwan. (A template as [Appendix 2](#): Guarantee of Financial Support for Admission).

5. **Proof of Nationality:**

According to the regulations of the Ministry of Education and the Ministry of the Interior, the applicants must submit their birth certificates, identifications of the parents and any document that shows their parental relationships, as well as the documents that certify the applicant's nationality:

- a. Photocopy of a valid passport or certificate of nationality
- b. Photocopies of the applicant's parents' passports or certificate of nationality
- c. Taiwan Alien Resident Certificate (ARC) (if applicable)
- d. « Forfeited Nationality Permit Certificate » issued by Ministry of the Interior for at least 8 years (for applicants who hold foreign nationality, and once held R.O.C. nationality)
- e. « Certificate of Entry/Exit Dates » issued by National Immigration Agency (for applicants both hold foreign nationality and R.O.C. nationality)

6. **Proof of Language Proficiency**

- a. Applicants must submit an English proficiency certificate at CEFR B1 or above. Alternatively, applicants can provide a school-issued document stating that their immediately preceding degree program was conducted in English.
- b. English Proficiency Requirement Form (as [Appendix 3](#))
- c. According to the announcements by R.O.C. overseas representative offices, international students are required to provide English or Chinese language certificate for Resident Visa for studying in Taiwan, such as Vietnamese, Indonesian, Thai and Myanma applicants, etc.. Please confirm with the authorities concerned for application requirements.

※ Students enrolled in the INTESE program must pass the listening and reading exam of the Test of Chinese as a Foreign Language (TOCFL) at level 2, equivalent to CEFR A2, by the end of the first semester of their second year.

8. **Two letters of recommendation** (in Chinese or English)



9. **Other documents specified by the INTENSE Program** (Please refer to “J. Admission Criteria of the INTENSE Program”)
10. **Passport size photograph:** a close-up shot of the head and shoulders (no hats/sunglasses/tinted glasses) within the last 12 months
11. **Self-Check for Eligibility Verification & Declaration Form** (as [Appendix 4](#))

Note: Incomplete application documents will not be reviewed.

E. Application Fee

No application fee required.



F. Scholarships

Recipients will receive a monthly living allowance of NT\$10,000. In addition, tuition and miscellaneous fees, initial administrative expenses upon first arrival in Taiwan, and one-time airfare will also be covered. However, the grant does not apply during any extended study period.

※ Obligations:

- (1) Students who receive grants from the university's partner enterprises are obligated to work in Taiwan for a corresponding period based on the duration of the grant received.
- (2) Recipients of a one-year enterprise grant are required to work in Taiwan for one year, while those who receive a two-year enterprise grant are required to work in Taiwan for two years.

※ Grant Repayment Principles:

- (1) If a student withdraws from the INTENSE program before completion or fails to fulfill the employment obligation after graduation, the repayment principles for the received enterprise grant are as follows:
 - a. Circumstances Beyond the Student's Control That Do Not Require Repayment of the Enterprise Grant:
 - i. If the original partner enterprise discontinues the living allowance due to operational adjustments during the student's enrollment, and the student is unable to secure another enterprise willing to continue providing the allowance despite the university's assistance, resulting in the student's withdrawal from the INTENSE program.
 - ii. If the original partner enterprise has no job vacancies upon the student's graduation due to operational adjustments, and the student is unable to find suitable employment despite the university's job counseling and matchmaking efforts.
 - iii. If, during the student's employment period, the partner enterprise commits any violation as specified in Article 14, Paragraph 1 of the *Labor Standards Act*, leading the student to terminate the contract, and the student is unable to secure suitable employment despite the university's job counseling and matchmaking efforts.
 - iv. If the student passes away or is unable to continue their studies or employment due to a severe illness or accident, as certified by a teaching hospital accredited under the Ministry of Health and Welfare's new hospital evaluation system, or if the student experiences a major family crisis that prevents them from continuing their studies or employment, as verified by the university.
 - b. Circumstances Attributable to the Student Requiring Repayment of the Enterprise Grant:
 - i. If a student withdraws from the INTENSE program due to personal reasons during their studies—such as transferring to another school or department, taking a leave of absence to return to their home country, or voluntarily abandoning the program despite university counseling—or if the student is expelled or dismissed according



- to university regulations, they must fully repay the received enterprise grant.
- ii. If a student demonstrates poor academic performance and fails to meet the evaluation standards set by both the university and the enterprise, and despite university counseling, fails to improve and is subsequently expelled or dismissed according to university regulations, they must fully repay the received enterprise grant.
 - iii. If a student, after graduation, chooses not to work for the partner enterprise or within a relevant industry, and fails to comply despite university counseling, they must fully repay the received enterprise grant.
 - iv. If a student is lawfully dismissed from employment due to violations of company regulations and fails to comply despite university counseling, they must repay the enterprise grant proportionally based on the number of months not employed. Any period of less than one month will be rounded up to a full month.
 - v. If a student resigns from the partner enterprise before completing the required employment period corresponding to the duration of the grant received, they must repay the enterprise grant proportionally based on the number of months not employed. Any period of less than one month will be rounded up to a full month.
- (2) During the mandatory employment period after graduation, students may, depending on the needs of the partner enterprise, be assigned to work at the enterprise's overseas branches or employed by Taiwanese businesses abroad. If a student fails to fulfill the employment obligation with the partner enterprise, they must repay the received enterprise grant proportionally based on the number of months not employed with the enterprise. Any period of less than one month will be counted as a full month.

- The following table shows the approximate tuition fees for academic year 2026-2027. The tuition fees must be paid when students register at the beginning of each semester. Any future changes to the tuition and miscellaneous fees will be made in accordance with the internal regulations of KMU.

I. Reminders & Admission Notice

- 【According to Article 2 of the *Nationality Act* of R.O.C.】

A person shall have the nationality of the R.O.C. under any of the conditions provided by the following Subparagraphs:

- His/her father or mother was a national of the R.O.C. when he/she was born.
- He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the R.O.C. at the time of death.
- He/she was born in the territory of the R.O.C., and his/her parents can't be ascertained or both were stateless persons.
- He/she has undergone the naturalization process.

The provisions of Subparagraphs 1 and 2 in the preceding paragraph shall be also applicable to those under the age of 20 at the time of the amendment and implementation of this Act on February



9, 2000.

2. According to the regulations of Ministry of Education, if the applicant has ever been expelled by any university or college in Taiwan under these circumstances (with drop-out records due to failure in conduct grades, failure to meet the prescribed academic requirements, or being indicted guilty by the criminal law, or seriously violated any ordinances or the regulations of the educational institution and as a result, had discontinued the study or forfeited the status as a registered student), the applicant is not allowed to apply to the university. Violation of this regulation will result in disqualification of admission regardless of the merits of the application.
3. An international student who after coming to Taiwan to study has been permitted to undertake initial household registration, resident registration, naturalization, or restoration of R.O.C. nationality procedures during the course of their studies in Taiwan will forfeit their international student status and shall be dismissed by their educational institution. However, this does not apply to a person in any of the following circumstances:
 - (1) The student's admission to their educational institution was handled in the same manner as for the admission of domestic students.
 - (2) The student applies for naturalization to acquire R.O.C. nationality in accordance with the provisions of Subparagraph 1 to Subparagraph 3, Paragraph 1, Article 4 of the Nationality Act.
 - (3) The student meets the criteria set out in the provisions of Article 2, Paragraph 1 and applies for naturalization to acquire R.O.C. nationality in accordance with the provisions of Article 3 to Article 7 of the Nationality Act.
4. No double identities (overseas Chinese students and international students): Applicants should decide with which status to apply from the very beginning. Those who study in Taiwan with double identities (overseas Chinese and international student) will have their recognized student status cancelled.
5. Enrolled students should pass the Graduation Threshold of English Competence set by each department/institute prior to graduation. Please refer to the website of each department/institute for the requirements.
6. At the time of the registration, admitted students should present proof of a medical and injury insurance documents which are valid for at least 6 months from the date of the arrival in Taiwan, or documentary proof of joining Taiwan's National Health Insurance Plan. The proof of insurance issued in a foreign country shall be authenticated by the R.O.C. representative office. KMU provides insurance application assistance to those who are not insured, and insurance payment should be made upon registration.
7. No application documents would be returned for any reason.
8. The degree awarded by each department or institute would follow the format announced by the



Ministry of Education, R.O.C..

9. Applicants graduating in the current year shall submit “the certificate of expected graduation” or “the certificate of enrollment” in the application period, and the diploma is required upon registration at KMU.
10. Obtaining admission status of KMU does not guarantee the issuance of a Resident Visa. If there is any problem related to Visa issuance, admitted students themselves should approach R.O.C. representative office in/near the country.
11. Regulation regarding working in Taiwan: International students must apply for a work permit to work in Taiwan and are not allowed to work more than 20 hours per week, except during the winter and summer vacations. Students shall follow the Ministry of Labor of *Employment Service Act* as well as the disciplinary action in accordance with the regulations of KMU.
12. Matters not covered in this Application Guidelines shall be handled in accordance with the Ministry of Education *Regulations Regarding International Students Undertaking Studies in Taiwan, Implementation Plan for Encouraging International Students to Come to and Stay in Taiwan – International Industrial Talents Education Special Program (INTENSE Program)*, the *KMU Regulations for Admitting International Students*, and other relevant regulations, or in accordance with the resolutions of the KMU Admissions Committee.

Appendix 6: Kaohsiung Medical University (KMU)

Guidelines for Refunds to Suspended or Withdrawn Students

September 11, 2013 Passed at the 1st Academic Affairs Meeting academic year 2013

November 8, 2013 Passed at the 3rd Administrative Meeting academic year 2013

November 21, 2013 Announced by KMU Academic Affairs Letter No. 1021103614

- I. These Guidelines have been established to handle matters related to the refund of fees to students who have suspended studies in KMU or withdrawn therefrom.
- II. Students applying for suspension or withdrawal from KMU shall be refunded according to the following ratios:
 - (I) Students who have applied for suspension or withdrawal prior to the start of school (inclusive) shall be exempt from paying any fees; students who have already been charged will receive a full refund.
 - (II) For students who apply for suspension or withdrawal after the start of school but before one-third of the semester has passed, two-thirds of the total tuition and miscellaneous fees shall be refunded to those on a full tuition and miscellaneous fees basis; and two-thirds of the total basic tuition and miscellaneous fees, credit fees, and remaining fees shall be refunded to those on a basic tuition and miscellaneous fees basis.
 - (III) For students requesting suspension or withdrawal after one-third of the semester has passed but not beyond more than two-thirds of the semester, one-third of the total tuition and miscellaneous fees shall be refunded on a full tuition and miscellaneous fees basis; and one-third of the basic tuition and miscellaneous fees, credit fees, and remaining fees shall be refunded to those on a basic tuition and miscellaneous fees basis.
 - (IV) No refund of full tuition and miscellaneous fees, basic tuition and miscellaneous fees, or remaining fees shall be made to students applying for suspension or withdrawal after two-thirds of the semester have passed.
- III. First-year and transfer students subject to the waitlist system who apply for withdrawal prior to the waitlist decision deadline (inclusive) shall receive a full refund; those who apply for suspension and those who apply for suspension or withdrawal after the waitlist decision deadline shall be refunded according to the previous regulations.
- IV. Students who have applied for suspension in the previous semester and continue to apply for suspension in the following semester are exempt from paying any fees.
- V. The base dates for calculating refund are as follows:
 - (I) For those who apply for suspension or withdrawal, the refund shall be calculated based on the date the student (or parent) submits the application for suspension or withdrawal to the Academic Affairs Office and completes the procedures for leaving school.
 - (II) For students who are subject to a suspension or withdrawal order from KMU, the refund shall be calculated based on the date of delivery of the suspension or withdrawal notice; however, if the student continues to attend school due to a suspension or withdrawal appeal process, the actual date of leaving school shall serve as the base date.
- VI. The calculation of the first day of school and semester as stated in these Guidelines shall be based on the official calendar published by KMU.
- VII. Students applying for suspension or withdrawal must prepare the original payment receipt and their account information, and submit them to the Office of Academic Affairs for refund in accordance with Article 2 of these Guidelines.
- VIII. These Guidelines were approved upon a resolution by the Academic Affairs Meeting and the Administrative Meeting, and implemented on the announcement date with the approval of the President. The same shall apply to all subsequent amendments.
